Franco Basaglia, the great Italian mental health reformer (1924–1980), started his work in the psychiatric hospital of Gorizia (1961–69), where the state border was its rear wall. When he moved to Trieste in 1971, he was able to close the first asylum in Europe through a process that led to the launch of the Italian Psychiatric Reform Law (1978). This law, closing all asylums, restored to the inmates all their rights as citizens and established community care as the rule in the country. This great example was paramount for the World Health Organization as best practice, while the Italian reform, supported by its law, became a point of reference for similar advancements in various countries, such as Spain, Portugal, Brazil, Argentina, among others. The Slovenian as well as the Italian communities have acknowledged his work as a great achievement not just for mental health and healthcare, but for civilization of mankind. Moreover, Trieste and the Region Friuli Venezia Giulia, including Gorizia, became the symbol of a whole system change, admired and studied by visitors from all over the world, and in the last decades, mental health services in Gorizia have developed cross-border collaborations for reforms.

The proposed 3-days conference will be advocating better mental health for individuals and communities, for the change of the culture to disabilities, for the recognition of the need of universal coverage, for a care that is accessible to all, in places where people actually live, outside institutions. While honouring the figure of Basaglia and his work, this conference would take over his legacy and establish a meeting point for good practice programs and services, for innovative policies, in Europe and beyond.

The opening of the border means also opening of people's minds, interchanges and shared knowledge, and, above all the affirmation of freedom as the proposition of care, stating its therapeutic value – as 'freedom is therapeutic!' is written on the walls of the Trieste former asylum. And this is the actuality of Basaglia and his work today. He transgressed the borders between normalcy and otherness, sanity and madness; yet also between the institution and the social environment – the community – between science and culture, between professions, disciplines, between social and health, between generations.

Today, as we **GO! Borderless**, these borders must be still overcome. Basaglian thought affirms madness as a legitimate part of human existence and as a social and cultural phenomenon. Basaglian approach creates the culture of not excluding and establishes inclusive interactions. The professional culture is being challenged and changed by contesting the traditional professional mandates, by an imperative of being creative, the involvement in the community, by the necessity of working in teams, collaborating with diverse groups and actors.

The truly Basaglian praxis of freedom, is perhaps more needed than before – in order to remain human in the face of dehumanisation brought on us by digitalisation, algorithms, increasing authoritarianism, rising global temperature and the struggle for remaining resources. It is a practical wisdom, optimism of the practice, of doing things together that can overcome the pessimistic outlooks for the future.

In the first two days, many experts and other stakeholders, people with lived experience, carers, policy makers, citizens, workers of culture and science of many countries would attend and present their experiences at this important event, as the crossroads of change and transformation. This will be complemented by presentation of books and films. On the last day, the attendees will have the opportunity to visit services and projects realized through this cross-border collaboration.

A final declaration will be delivered to EU, the WHO and the UN.
